#### Approve Agenda

President Lollar asked to consider the September 12, 2023, meeting agenda.

Bill Simshauser made a motion to approve the agenda as presented. Gina Gigot seconded. The motion passed.

# Approval of Minutes

President Lollar drew the board's attention to the July 11, 2023, and August 15, 2023, minutes. Bill Simshauser moved to approve the minutes as presented. Gina Gigot seconded. Motion passed.

#### Presentations

# National Water Quality Initiative-Scott Satterthwaite, KDHE

Scott Satterthwaite spoke to the group on the NWQI (National Water Quality Initiative) through NRCS, which is a way for States to partner with NRCS to develop a plan. Scott stated the planning information, which included the HUCK 12 along with budget information, was sent and noted the KGS study would be completed. Scott did send a copy of the planning request to Trevor if anyone would like to see it.

#### Brief Update on Grant Proposals-Trevor Ahring

Trevor Ahring updated the group on the grant proposal. GMD3 is working on a Reclamation Water Strategy Grant. The City of Deerfield may submit a Project Design Grant. The Project Design Grant is for projects to conduct project-specific design to improve water management or water supplies. Grant proposals are due October 13, 2023.

GMD3 is looking to utilize the hydrologic models completed by the Kansas Geological Survey. They will have the GMD3 model completed by the end of the year. Results from modeling of prediction changes over time in crops grown and acres irrigated, we can build our own statistical analysis. Then, create a production model with K-State researchers to predict surplus and deficit resources to meet economic demands. The Grant Funding will also assist GMD3 in facilitating stakeholder meetings. Any stakeholder interested in seeing conservation plans in SW Kansas and willing to offer facilities contact us. A few suggestions include:

- ✓ Deerfield Community Building, especially working with the City of Deerfield
- √ Fairgrounds at Lakin,

Trevor touched base on the City of Deerfield Proposal; this grant opportunity allows them to seek \$400,000 for engineering and project design with no match. They have three municipal wells; one is over the standard drinking water with uranium. They are currently converting that water right to irrigation. This grant would allow them to engineer the water piping or build a facility.

# **Old Business**

Trevor handed out to the group a proposal from USGS identifying contamination sources at Stateline Groundwater Gage. The proposed budget includes four wells in Kansas and four wells in Colorado. There are three scope options to consider. Scope one is continuous real-time data, Scope two is continuously recorded data, and Scope three is discrete measurements. However, note that drilling new monitoring wells is not included in the estimated cost option. The question to the table: how on board is Colorado in finding the source of the contamination? Keadron Pearson stated that based on the water quality initiative (Ark River Water Quality Interstate Network), Colorado is aware of their quality issues and feels they will be open-minded. Kevin remarked that nowhere in the proposal does it show 50-50 cost share, and nowhere does it say co-op, so might want to double-check that.

Bill Simshauser moved to add this to the list of projects. Monty Morgan seconded. Motion passed

# **Fundraising**

Trevor reviewed the fundraising projects, float trip down the river, trap shoots, and Brewery Night at Hidden Trail were a few already listed. The float trip may have to wait for next year due to the weather and getting all the details in order. Trevor and Jason spoke to Hidden Trail about a fun night. They have several ideas and would like to help with a night at the brewery. The Brewery Night would be an excellent fundraiser; it is easy and doesn't have too much upfront cost. What is the financial goal for the group? The beginning goal for monies in our bank account is \$5,000. Bill Simshauser moved to proceed with the Fundraising event at the Hidden Trail Brewery. Gina Gigot seconded. Motion passed.

Mark Rude added that if anyone wants to donate funds before the legal paperwork is complete, the funds could be run through the GMD3 account.
